5 Entries

Entry procedure

• Entries must be submitted via: <u>www.rallyscore.net</u> . This is a two-part process.

- All details entered MUST be true & accurate for ASN and MCMC Seeding purposes.
- Entries must be paid in full, including insurance for the Event.
- Membership of MCMC is necessary.
- An Entry will only be accepted when accompanied by the total Entry Fee.
- TBA can be used but note <u>only one amendment</u> per Entry can be made
- Payment of Entry Fee is via BACS details:- will be advised on Rallyscore.

Entry Selection Criteria

Places will be allocated - following the Closing Date for Entries - to **Drivers** in the following order:

- 1. MCMC reserve the right to select 20 competitors at their discretion.
- 2. Any current MCMC member prior to publication of these Regulations

ALL of the above is based on receipt of fully completed Entry Forms and payment.

If more than 80 Entries have been received at the closing date a reserve list of up to 20 potential Competitors may be assembled. All the correspondence will be posted on www.maidencitymotorclub.co.uk On submission of your Entry your will receive an email of acknowledgement, reserving entry.

You will NOT receive any written correspondence in relation to the Event from the Club.

It is your responsibility to check webpage/Sportity regularly.

Additional Information re: Accepted Entries

- The number of Competitors shall be limited to 80 plus 20 reserves and the minimum will be 70. The minimum entry for each class is 3. Should the minimum figure not be reached, the Organisers reserve the right to cancel the Event or to amalgamate classes or reduce the awards list as deemed appropriate. Cancellation of the event will result in a full refund.
- Competitors are advised that when completing the Entry Form online please do this as fully as possible, only ONE amendment to the form is allowed i.e. driver/navigator details, car or class until seeding of Entries.

NB. When seeding is completed, the named driver CANNOT be changed.

- The starting order will be at the Organisers' discretion, but to assist seeding, Entrants must note their previous Results on the Entry Form. Failure to disclose previous Results may lead to incorrect seeding, which may not be rectified.
- Any indemnity and/or declaration as prescribed below which is signed by a person who has not reached their 18th birthday must be countersigned by that person's parent or

guardian, whose full name and address must be given. Any Entry may be made by electronic means of communication must be made by the parent or guardian, whose full name and address must be given (Ch.6 App.1 Arts.10-13 and Ch.3 App.5 Art.3.3.1.h)).

- Any person under the age of 18 signing (where the parent is not present) must be accompanied by a Guardian who must produce a written and signed authorisation from the Parent to act as Guardian (Ch.3 App.4 Art.3.2.)
- Organisers reserve the right to accept or refuse Entries at their discretion.
- All Entries will be acknowledged but will not be eligible for selection to compete unless FULL payment of the Entry Fee has been made.

Entry fee refunds

(follows guidelines issued by ANICC Stage Rallies Committee)

• Entry Fees where refunded shall be subject to the deduction of an administrative charge of £50.00 up to 23:59hrs Saturday 20th December 2025. From Sunday 21st December 00:01hrs to Tuesday 23rd December, Entries will be refunded less an £100 administration fee. After this time and date refund of Entry Fees will be at the Organiser's discretion. Reserve entries that are not offered a start will receive a full refund subject to (Ch.6 App.1 Arts.11.1.b)

Class Notes from ANICC Rallies Specialist Committee Championship Regulations:

ARTICLE 5 - VEHICLE CATEGORIES AND CLASSES

- 5.1 Overall Class 1 (32mm turbo restrictor only) and Classes 2-10 and Class H. Turbo restrictors for Class 1 cars may be checked and/or sealed by the Championship Eligibility Scrutineer at any point on any Championship event.
- 5.2 NOT USED.
- 5.3 Two Wheel Drive overall Eligible 2WD cars in classes 3, 5, 6, 7, 8, 9, 10 and H.
- 5.4 NOT USED.
- 5.5 The Class championships will be divided into eleven Classes.
- 5.6 All cars must comply with the current 2025 Motorsport UK vehicle regulations (including the requirement for all vehicles to produce a logbook or vehicle passport) appropriate to the individual event entered.
- 5.7 Competitors are reminded of requirements under 2025 Motorsport UK NCRs; 7.4.6 and 8.1.1.5 where all cars must be equipped with the facility to enable a fuel sample to be taken.
- 5.8 All cars must have Mud Flaps fitted behind each wheel. See 2025 Motorsport UK NCR 13.16.3.13.
- 5.9 See 2025 Motorsport UK NCR 7.2.22.15-16: All competitors must carry within their vehicle a selfcontained Spill Kit capable of effectively absorbing minor spillages of up to 1.25 litres of all vehicle fluids oils, fuels, coolants, battery acid. Used Spill Kits are to be

disposed of in accordance with local or National guidelines and or Venue Regulations. They must not be disposed of in general waste facilities at the Event.

- 5.10 All Turbo engined cars, class determined by capacity x1.7; All Rotary engined cars, class determined by capacity x1.7.
- 5.11 Vehicle Regulations for homologated and previously homologated cars in classes 1.
- 3, 4, 5, 7, and 8: The relevant FIA Homologation Papers must be produced at each event and cars must comply fully with FIA technical eligibility regulations (FIA Appendix J).

Previously homologated cars are defined as cars whose homologation has expired, and they are permitted to compete in a previously homologated specification.

- 5.11.1 In all cases the degree of modification from standard shall be as provided for under FIA technical eligibility regulations (Appendix J).
- 5.11.2 The onus of proving eligibility for any homologated car rests solely with the competitor who should ensure that homologation papers are available at events.
- 5.12 The onus is on every competitor to ensure that they are entered each championship event in the correct class.

6. LICENCES

Day of Rally: Monday 29th December.

Minimum Acceptable Licences

Drivers: RS Interclub Stage Rally or above.

Co-Drivers: RS Interclub (UK Only), RS National, Race National, RS Rally National Navigator and any International Licence.

Drivers and Co-Drivers must send a picture of their licence to the Secretary via Rallyscore for checking on application, for compliance. This licence will also be checked at paper scrutiny.

NOTE:- Co-Drivers ONLY, Licence's CAN be applied for via the club on the morning of the Event - This licence will only be valid until end of December 2025!!

Navigators who do not have a licence must do so by applying to Motorsport UK BEFOREHAND, using a downloadable form, RETURN TO Motorsport UK or bring to Rally Office along with a photograph and correct fee (RS Interclub (UK Only) £82) before Scrutiny.

NOTE: RS Clubman (UK Only) and RS Interclub (UK Only) Licences are NOT valid for driving on ANY Special Stage Rallies under any circumstance.

Competitor Sign-on

Competitor(s) Sign-on for those selected to compete will be in person on the day.

7. Advertising and Identification

Competitors must make available to the Organizers of the event specific areas (Ch.6 App.1 Art.9) on the vehicle as shown on the diagrams in Appendix 2. The organisers will supply all Event decals including door plates, door headers, and Competition Numbers.

8. Trailer Park /Scrutiny / Service Area Trailer Park

A trailer park will be available within the grounds of the Shackleton Complex, Ballykelly. Please follow Marshals directions in relation to parking.

Scrutiny

Main Scrutiny will take place for Competitors on Monday 29th December 06:00 – 08:45hrs

The gates of the service area will open at 18:00hrs on Monday 29th December.

Noise Test, Scrutineering of Vehicle & Driver/Navigator's safety

equipment Rally Cars must be presented in same condition as they intend to compete. A valid MOT/NCT Test Certificate, Tax, must available for production at Scrutineering for any Car required by UK law to have one.

A Noise Test, Inspection of Driver & Co-Driver's Rally wear, Helmets/FHRs of ALL Cars will take place in the Service Area from 06:00hrs -08:45hrs.

The Scrutineering Team will assess ALL Cars.

<u>All Cars must carry</u>: OK/SOS board, Warning Triangle, Spill Kit. All reports, e.g. Non- Compliance, Noise Schedule, etc will be passed to the Stewards and the Clerk of the Course.

Failure to attend scrutineering within the time specified = Disgualification.

Service Area

Reminders within the service area:

- Drive with respect and responsibility within the service area. i.e. 5-10mph
- Only one Service Plate will be issued per Competitor. Strict limitation of Vehicles entering Service Park will be in place. NO PLATE NO ENTRY.
- All Crews MUST provide and use a ground sheet as the grounds are kindly on loan by the local business.
- The service van must carry a Fire Extinguisher.
- Refuelling As the total event is less than 36 miles, there is no reason why 1 tank of fuel will not suffice. YOU SHOULD ARRIVE WITH THE FUEL ALREADY IN THE CAR.
- Please use the bin provided for the oil and rags.
- Crews and Service Crews MUST obey the instructions of all Marshals on the Event at ALL times.

Any crewmember or member of a service team found outside the allocated Service
Area (i.e. on Shackleton runways or prohibited area) will be reported to the
COC/Stewards and result in immediate exclusion from the event.

9. Route and Special Stages / Reconnaissance:

- 9.1 Cars will start at 30 second intervals. First car will leave the start no earlier than 09:15am on Monday 29th December 2025.
- 9.2 Start Order will be published online, MCMC website and Rallyscore at 09:00 on Monday 29th December.
- 9.3 The event will consist of 5 special stages with a mileage not more than 36 miles (57km).
- 9.4 The stages will be run at a single venue, Shackleton.
- 9.5 Auxiliary lighting may be required as the sunset will be at 16:08hrs.
- 9.6 Approved sketches which define special stage routes will be available on the Virtual Noticeboard before the event. **See regulation 9.8** No paper copies will be available at the event.
- 9.7 These stages will be timed to an accuracy of less than one minute in accordance with R2.7.2. The stage will take the form of 100% sealed surface.

TO BE DECIDED BY MOTORSPORT UK

9.8 Reconnaissance/Safety Notes

- 9.8.1 Subjective Route Notes **MAY** be permitted on this event, subject to approval from Motorsport UK.
- 9.8.2 Competitors will only be permitted to examine the stages between 06.30hrs and 08.45hrs on Monday 29th December **on foot or bicycle only**. Anyone who uses any other person(s) to do so on their behalf will be excluded from the event and will be reported to Motorsport UK/Motorsport Ireland. **NO motorised forms of transport permitted.** Any competitor who has been authorised by the Clerk of Course to work on a special stage will be exempt from exclusion.
- 9.9 From publication of these Regulations any Competitor found on the Stages, will be **Disqualified** with NO EXCEPTIONS!!

From the date when stage setup commences, in December, no 'practicing' or 'testing' can take place by any competitor or agent, who has already entered or expects to enter, the 2025 Turkey Run event. This includes any individual or group who enters a hire agreement with the owners of the Shackleton Complex.

To enforce this Regulation all the people named in these SR's (and additional Final Instructions and any published Official Documents) have been appointed Judges of Fact.

• A Competitor who practices, reconnoitres or otherwise examines a Special Stage or uses any other person(s) to do so on their behalf, will be Disqualified from the Competition without refund and reported to the ASN / Motorsport Ireland in the case of MI Licence Holders— THIS WILL BE STRICTLY ENFORCED.

In all circumstances, Competitors are advised that the Organiser accepts no liability or responsibility in the use of the subjective route notes.

Special requirements

Competitors wishing to carry on board camera(s) during the Event must declare to the Chief Scrutineer on arrival at scrutineering and complete the necessary documentation (Ch. 6 App. 9 Arts. 1.4 & 1.5). Cars must be presented at scrutineering with the camera(s) fitted. Cameras that are affixed to the outside of the Vehicle by temporary fixing devices including, but not limited to, suction devices, must also be attached to a permanent bracket or non-removable bodywork by means of a restraining strap. Cameras that extend outside the extent of the door mirrors when viewed from the front of the Vehicle are prohibited.

The Organiser may request the removal of video footage from on board cameras deemed to be offensive or of a sensitive nature should it be posted on the internet or social media websites. Any Competitor who does not comply with this request may be reported to the ASN for consideration of disciplinary action and which may involve interim suspension of Licence.

10. Timing/Timecards

For all sections of the Event Timing is set to BBC/BT Timing, and will be timed using Digital clocks to 1/10th of a second from standing start to flying finish on Roads closed to the Public. (Ch.13 App.13 Arts.8.4).

Cars will start at 30 second intervals.

The starting for Special Stages will be given by means of "Start Light Signals" which will work as follows:

30 seconds	RED light will be displayed	
15 Seconds	RED and AMBER lights will be displayed	
10 Seconds	RED light will go out	
5 Seconds	AMBER countdown 5,4,3,2,1	
START TIME	GREEN light goes ON	

The finish time will be displayed on screen in hrs, mins, seconds and 10ths of a second with your Car number. It is up to the navigator to record their time on their timecard. The definitive checks will be the stored times in the clock and the Marshals check sheet.

All Controls will open 15 minutes before the Due Time of the first Car and close 15 minutes after the Due Time of the last Competitor still running (Ch.13 App.13 Art.3), having taken into account any delays.

Missing a control or stage

Crews are reminded that it is their responsibility to ensure their Car is SAFE to compete. This includes after an incident, continuing to compete in a vehicle unfit to drive on the public highway will be considered bringing the sport into disrepute and shall be referred to the ASN for consideration of disciplinary proceedings.

Crews missing a Control or Special Stage will be penalised in accordance with Ch.13 App.8 Art. 1.3(a)(i) and will incur the appropriate penalty.

Restart After Retirement

- Any crew which has failed to complete a section can re-start the rally from the start of the next section if they confirm their intention to the Competitor Liaison Officer thirty minutes prior to first car due time of the subsequent section (Service Out Control). The competitor must advise the organiser of the reason for retirement (e.g., accident, technical problems, etc.). This shall apply to any car which has been not classified on the grounds of exceeding the time limit or has failed to report to a control but shall not apply where the car has been disqualified for breach of eligibility requirements, traffic infringements or by a decision of the stewards.
- For all crews which re-start a time penalty will be applied. This time penalty will be as follows: For every stage missed: 10 minutes. This time penalty will be added to the fastest time of the driver's class for each missed stage, which shall include the special stage on which the crew has retired.
- Competitors restarting the next section must present their cars to the scrutineer at the Service out control at the start of the next section at least 30 minutes before the start time of the first car. The car must retain its original shell and engine block as marked at preevent scrutineering.
- Any crew which has retired from the final section will not be classified as a finisher

Red Flag Procedure

Competitors are reminded to read and understand the Red Flag Procedure as prescribed in (Ch.13 App.10 Arts.7.31 & 7.32.).

"On passing a Red Flag displayed by a Marshal wearing a Marshals' tabard, the Driver MUST immediately and significantly reduce speed as well as being prepared to stop at any time; at no time must they overtake any safety vehicle they encounter on the Special Stage route. The Driver must then follow the instructions of any Marshals and/or Stage safety personnel and maintain this reduced speed until leaving the Special Stage.

Failure to comply with this rule will incur a Penalty at the Judicial discretion of the Clerk of the Course.

11. Penalties

Each Special Stage will have a Bogey Time set at 80mph for unsealed surfaces which will be indicated on the Time Cards

Competitors will receive Penalties on Special Stages as follows:

- Under Bogey Bogey Time
- Over Bogey Actual Time Taken
- Stage Maximum
- Over Stage Maximum Stage Maximum

Competitors will start with zero time Penalties. The Results will be established by adding the times taken during the Special Stages and the Time Penalties incurred on the road sections together with all other Penalties expressed in time. The Competitor with the lowest total will be the winner and so on. (Ch13, App13, Art 14.2).

If there is a tie, the Competitor who accomplished the best time for the first Special Stage will be declared the winner. If this is not sufficient to be able to decide between the tied Competitors, the times of the second, third, fourth etc. Special Stages will be taken into consideration. (2025 NCR Ch13, App 13, Art 14.3).

Penalties for lateness will apply.

11.30 Stage Starts will be indicated by means of a Flag or other type of Signal. After the Signal the Competitor will accelerate into the Stage. All Special Stages have a flying finish. Instructions on how to use the beam timing system will be provided in Final Instructions or other Official Document.

12. Driving Standards Observers/Judges of Fact

Driving Standards Observer's/Judges of Fact will be named (in Official Documents published on the Official Notice Board) for the Event to be on duty throughout the recce and on the day of Rally. Their report may result in the imposition of a Penalty for excess speed or bringing the sport into disrepute shall also be reported to the Stewards of the Event (Ch.13 App.12.).

Should any Special Stage be cancelled during the Event, or deleted from the Results after the Event, only the Stage Penalties will be deleted. Unless an Official Document has been published to the contrary, the cancelled Stage must be traversed within the Stage maximum time and will in every other respect be treated as a road section.

All start Officials on all Special Stages are appointed Judges of Fact for false starts. (NCR Ch.13. App.2.Art.4.40d).

The Organiser may appoint Driving Standards Observers in accordance with (Ch.5 Part B, App.6

Damage Declaration

Competitors must complete a declaration that they have/have not been involved in any incident resulting in damage to private property or injury to persons or animals or alternatively giving details of any such incident where damage or injury has occurred (Ch.13, App.13 Art.14.4)

This declaration must left in the box provided at the finish ramp. If a Competitor fails to reach the finish ramp the declaration must be completed and returned to the Rally Office or to the Event Secretary within 72 hours of the finish of the Event (Ch.13 App.13 Art.14.5)..



Ref: Championship Regulations - APPENDIX 2: GRAPHICS PLACEMENT

This Bulletin defines the required graphics to be carried by competitors in the above Championships and should be read in conjunction with the respective Championship Regulations.

A. Championship sun strip.

To be attached and clearly visible on the outside of the front windscreen of the competing car. Sun strips must not obscure the driver's vision nor cover more than one third of the depth of the visual area of the windscreen (NCR 12.13.2.3 and 13.15.3.12). Individual sun strips should not exceed 13cm in depth (NCR 6.1.9c) and the Championship sun strip must extend the full width of the windscreen and must not be trimmed to any less than 12cm in depth when fitted.

To be supplied by the Championship.

B. Championship door plate.

Including up to 645 sq. cm at the top for event advertising and up to 645 sq. cm at the bottom for Championship advertising (NCR 6.1.9). Competition numbers must comply with NCR 7.10 with a white space of at least 48cm x 33cm (NCR 7.12 Diagram 1).

To be supplied by event organisers.

C. Side windows

In accordance with NCR 13.9.5.4b Competition Numbers for each rear side window (or equivalent area on smaller Vehicles) shall be 200mm high with a stroke width of at least 25mm and a minimum separation of not less than 25mm and coloured yellow or orange and which may be reflective.

D. Rear window

Further in the bottom of the rear screen (or equivalent space on two-seater cars) the Competition Number shall be displayed black numbers on a 180mm x 180mm white background. This number must be visible from the rear of the Vehicle at eye level but must not impede the rear view via the rear view mirror.
